Respected Sir,

I and my siblings were residing in the above address since April 2023. On the 4<sup>th</sup> of May Meitei Mob led by Arambai Tenggot Miscreants attack our locality pelting stones and petrol bombs desecrating Kuki Baptist Convention (KBC) Church New Lambulane. Fearing for our life we were escorted to Leimakhong Indian Army HQ under the protection of Assam Rifles. On the 12<sup>th</sup> of May the Army dropped us to Imphal airport and then we flew to Shillong.

I and my siblings had to flee the state, being Kuki tribe, fearing for our life. We had possessions including furniture, jewellery, electronics, and various household materials worth Rs. 20 Lakhs (approx.) in our house, one Four wheeler and one two wheeler worth Rs. 12 lakhs (approx.), and a house plot at National Game village worth Rs. 7 lakhs. We had no idea if anything is still intact, looted or destroyed, or will be retrievable in the near future.

Hence, I request that you will investigate the matter and take proper action against the perpetrators.

We are hoping for justice for all who are in this plight.




