Respected Sir,

I am resident of the above address since last 1982. On May 3rd at around 7.00 pm in the evening a mob (about 250) from Meitei community started attacking and burnt our local neighbours' house, vehicles and churches carrying various weapons. As the mob attacked Kuki-Zo tribe I am compelled to take shelter at our nearby Muslim House and I stayed there till 11th May 2023. On the same day I was escorted by the CRPF to the Airport at Imphal and I came to Shillong.

I was targeted because I am from Hmar Community and a Christian. Presently I don't feel safe about going back to my home because there is no safer place to take shelter and my life is at stake. I have a property worth 2.3 crores. I have a car Maruti A Star. I am afraid that my possession can be destroyed or looted by the miscreants. Kindly ensure that my life and property are safe.

We are hoping for justice for us and all our people from this situation.




