Respected Sir,

I am resident of the above address since last 1982. On May 3rd at around 7.00 pm in the evening a mob (about 250) from Meitei community started attacking and burnt our local neighbours' house, vehicles and churches carrying various weapons. As the mob attacked Kuki-Zo tribe our family consisting of parents and 3 children felt that we were not safe anymore so we were compelled to take shelter at our nearby Muslim House and we stayed there till 06th May 2023. On the same day we were escorted by the CRPF to the Airport at Imphal and we came to Shillong.

We have to re-admit our children schooling in Shillong till the situation in Manipur comes to normal, which really hampers their studies.

I was targeted because I am from Hmar Community and a Christian. Presently I don't feel safe about going back to my home because there is no safer place to take shelter and our life is at stake. I have two properties worth 2 crores. I have a Tata Tiago Car and Activa 110 CC in Imphal. I am afraid that my possession can be destroyed or looted by the miscreants. Kindly ensure that our life and property are safe.

We are hoping for justice for us and all our people from this situation.
