Respected Sir,

I am resident of the above address since last 1980. On May 3rd at around 7.00 pm in the evening a mob (about 250) from Meitei community started attacking and burnt our local neighbours' house, vehicles and churches carrying various weapons. As the mob attacked Kuki-Zo tribe our family consisting of parents and 1 children felt that we were not safe anymore so we were compelled to take shelter at IGAR South Camp Mantripukhri and we stayed there till 12th May 2023. On the same day we were escorted by the CRPF to the Airport at Imphal and we came to Shillong.

I was targeted because I am from Hmar Community and a Christian. Presently I don't feel safe about going back to my home because there is no safer place to take shelter and our life is at stake. I have Aactiva 110 CC and household goods in Imphal. I am afraid that my property can be destroyed or looted by the miscreants. Kindly ensure that our life and property are safe.

We are hoping for justice for us and all our people from this situation.

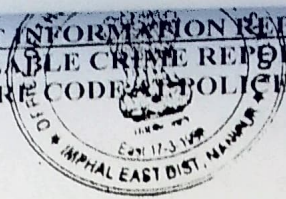
