Respected sir/mam,

We are the residents of the above address for the past 27 years and on 3<sup>rd</sup> May 2023 we heard about the attack on the localities and villages in and around Imphal by the Maaitie mobs, Meitei leepoon mobs with Aarombal Tengol. We were very afraid and started looking for ways to escape. On the 6<sup>th</sup> we went to Assam Rifle Transit Camp near Minuthong Bridge and then on 8<sup>th</sup> along with the convoy to Kankopi District. Then we moved to Shillong.

When we escaped we could not carry any of our belongings, we had to escape taking nothing with us. We are currently in Shillong and we are scared that our belongings and house back in Manipur will be vandalized or robbed or burned. As we have been hearing that the same has been happening in Manipur.

I have 5 children of which one is specially abled, who were all pursuing their education in and around our locality. But now their education has been disrupted and they are filled with fear. Due to the displacement, me and my family have gone through terrible losses financially and are suffering from mental trauma and are left with no hope.

Kindly, give us protection to go back to our homes and take legal action against the perpetrators who are causing threat to our lives and also provide protection to our locality so that our houses will be protected from vandalism and theft.
