We are the residents of the above address for the past 40 years and on 3rd may 2023 we heard about the attack on the localities and villages in and around Imphal by the Maeitie mobs, Meitei leepun mobs with Aarambai Tenggol. We were very afraid and started looking for ways to escape. On the 4th we went to Ist MR Camp and then on 7th along with the army convoy to Kangpokpi District. While we were trying to escape also, the mobs were after us and trying to attack us. Somehow we managed to stay alive. Then we moved to Shillong.

When we escaped we could not carry any of our belongings, we had to escape taking nothing with us. We are currently in Shillong and we are scared that our belongings, vehicles and house back in Manipur will be vandalized or robbed or burned. As we have been hearing that the same has been happening in Manipur. My tribe is being attacked because be are Christians and these mobs plan to eliminate all Christians from their land.

I have 4 children and they are filled with fear. Due to the displacement, me and my family have gone through terrible losses financially and are suffering from mental trauma and are left with no hope.

Kindly, give us protection and take legal action against the perpetrators who are causing threat to our lives and also provide protection to our locality so that our houses will be protected from vandalism and theft.
