

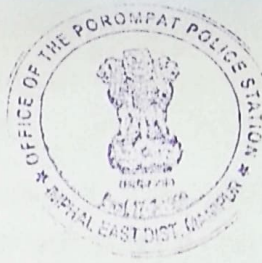

We are the residents of the above address since 2016 have been staying on a rented house. On the 4<sup>th</sup> May, 2023, we were forced to leave our house with nothing, but with the clothes on our backs. We took refuge at 1<sup>st</sup> MR Battalion Headquarters, Old Lambulane, Imphal west, Imphal. Our house and all properties inside where vandalized, burnt and stolen. We stayed at the above paramilitary camp from 4<sup>th</sup> May to 10<sup>th</sup> May 2023. We left Imphal on 11<sup>th</sup> May 2023 for Kolkatta and then from Kolkatta to Guwahati and then to Shillong on 15<sup>th</sup> May 2023.

Who were the ones who attacked you?

- Arambai Tenggol, Meitei Leepun and Meitei mobs. We were attacked because of hatred and intense jealousy. I am an Assistant Professor at Indira Gandhi National Tribal




