


I learned that all of my belonging that I left in my house are looted. The approximate cost of my belonging is around 2 lakhs including the shop property and vehicle.

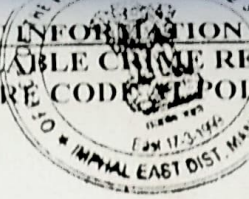
Respected sir,

We are the resident of the above address since 2000. ~~years~~ On the 4th May, 2023 the Arambai Tengol (15 in number approx) came to our house asking if we are Kuki tribe. And they said they will killed if we are Kuki. They had arms in their hands they all wore black shirt. One of them ~~said~~ asked someone on phone to ~~toot~~ collect the arms from Porompat police station. They asked if there is any male in the family. They even lie saying Kuki tribe has rape 20 more than 20 ~~mai~~ ^{women} ~~meilei~~ ^{people}. After around 1 hr they took us to 2nd M.R. North B.O.C. we stayed there till 6th May. On 7th May we reach Shillong.

After few days, we learned that our house ~~was~~ was looted and our shop too worth 2 lakhs.

My newly bough Jupiter 2-wheeler was taken by Arambai Tengol on 4th May and I never got back.
