Sir,

With due respect, I the undersigned would like to make a report to your good office about the attempt to murder committed by the Meitei mob while I was inside my room at JNIMS P.O&P.S. Porompat District Imphal East on 4th May, 2023

At the very outset, I would like to draw a few-line for your information that in the intervening day some mob (Meitei) entered our girl Hostel at around 7:00 pm and they were searching for any Kuki/Zo people residing there while they were shouting anti tribal slogans like 'Hao Hatlo' /Kuki Hatlo. Fortunately, I managed to escape from these criminals who tried to kill/burn me alive.

I request you to take strong actions against the perpetrators by registering a FIR/ZERO FIR under relevant criminals' provisions of law.


