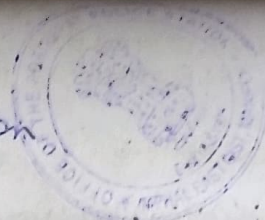

I have the honour to state that, on the midnight of 3rd May 2023 at around 8pm some unknown miscreants belonging to Meitei Youth Organisation suspected to be Members of Arambai Tenggot, World Meitei Council (WMC) Meetei Deepul and Kanglipok Kambol Ap (KKK) and Scheduled Tribe Demand Committee (S.D.C) numbering about 1000 members attacked my residence as tenant at Chassad Avenue, Imphal East. They looted all valuables and the approximate value of lost and destroyed properties to be about 20 Lakhs.

It is therefore, requested to kindly register a regular case and take necessary legal action according to law.
