Subject: Attack on lives and properties and subsequent FIR.

Sir,

I, LAMKHOVAH HAOKIP of Haokip Veng, House No. 7, Imphal, would like to lodge an FIR complaint against the Meitei radical group widely known as Arambai Tengtol, Meitei Leepuns, etc who have caused severe havoc and destruction upon my colony, burning and looting properties. My family narrowly escaped with our lives. List of my properties lost in the attack are appended below.

Therefore, I request for immediate action to this effect.

List of Properties lost in the attack:

1. Two storey building and land worth Rs. 5.9 crore.
2. Cash looted Rs. 20 lacs.
3. Ornaments (gold, silver and traditional) Rs. 30 lacs.
4. Sony TV with speakers Rs. 1.2 lacs.
5. Computer sets with printer worth Rs. 2 lacs.
6. Electric Inverter with battery worth Rs. 40000/-
7. Coffee machine Rs. 35000/-
8. Gas stove with 3 cylinder (3 Nos) Rs. 15,000/-
9. Wooden almirah (4 Nos) worth Rs. 3.6 lacs.
10. Sofa set (2 Nos) Rs. 3 lacs.
11. Iron almirah (3 Nos) Rs. 1.2 lacs.
12. Bicycle (3 Nos) Rs. 65,000/-
13. Wooden bed (5 Nos) Rs. 2.5 lacs.
14. RO water filter Rs. 5000/-
15. Water storage Syntex (3 Nos) Rs. 21000/-
16. Washing machine (2 Nos) Rs. 45,000/-
17. Microwave oven Rs. 25,000/-
