Sir,

It is to inform you that, on the 4th May 2023 at around 1pm, unknown, miscreant numbering about 1000 people suspected to be members of Ahambei Tengol, Kanglipak Kanba Lup, Meitei Deepun and Meitei St Demand committee pelted stones and damaged all the house windows. After wards they forcefully entered our house and damaged our properties and also looted all our precious belongings and later burnt down our house. On the incidence, my house was also burnt-down and so many other valuable electronic materials were also looted away and damaged properties worth around Rs. 2,75,61,400/-
