With due respect I have the honour to state the following few lines for your kind perusal and necessary action. That, on 22/05/2023 at around 04:00 pm received a reliable information that on the same day at around 03:00 pm, some unknown miscreants belonging to Meitei community burnt down my house at Chassad Avenue, Nongpok Ingkhol, P.O & P.S – Porompat, Imphal-East, Manipur to ashes which was already left unattended since I along with my families had fled for our lives to Kangpokpi Head Quarter on 03/05/2023. Mentioned may be made that, since the day I fled from my residence to Kangpokpi, the Meitei peoples keep on vandalising and looting my valuable household materials.

The approximate value of vandalised, looted and burnt down properties is 20,000,00/- (twenty lakhs) only.

It is, therefore, kindly requested to take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. I hereby lodged my complaint report at Kangpokpi Police Station as I had fled from my residence to safe myself and my familes from the rioters.
