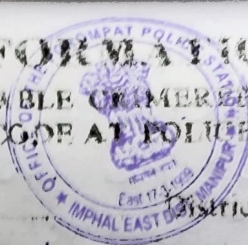

I have the honour to state that, on 4/5/2023 12 noon some unknown miscreant belonging to Meitei Youth of Arambai Juggot, Meitei Council (WMC) Meitei Deepen and Kangleipah Kanba Lup (KUL) numbering about 800-1000 members carrying sophisticated weapon like AK Rifles, SLR and 303 rifles forcefully entered in my house Hachip Veng Imphal East Porompat - Imphal, after looting all the valuables household properties, has been burnt down to ashes leaving us estimate at about 5-6 crores
