I have the honour to state that, on 4/5/2023 12 noon some unknown miscreant belonging to Meitei youths of Ahamberi Tenggot, Ward Meitei Council (WMC) Meitei Deepen and Kangpokpi Kanta Lup (KUL) numbering about 800-1000 members carrying sophisticated weapon like AK Rifles, SLR and 303 rifles forcefully entered in my house Haukip veng Imphal East Parompat - Imphal, after looting all the valuable household properties, has been burnt down to ashes leaving us estimate at about 5-6 crores

It is therefore, requested to booked the culprits and take necessary legal action according to law.
