Sir,

It is to inform you that, on the 4<sup>th</sup> May, 2023 at around 1 pm, unknown miscreants attacked Haokip Veng Palace Compound Imphal East. The unknown miscreants numbering about 1,000 people suspected to be the members of Arambai Tengol, Kangleipak Kanba Lup, Meitei Leepun, and Meitei ST Demand Committee pelted stones and damaged all the house windows. Afterwards they forcefully entered our house and damaged our properties and also looted all our precious belongings and later burnt down our houses. In the incidence, my house was also burnt down and so many other valuable electronic materials were also looted away and damaged properties worth around Rs. 2,7561,400/-

(Assets Lost : Building Rs.2,70,00,000/- Properties Lost : Rs. 15,93,000/- and One Four wheeler Alto Car MN01X3687 Worth Rs. 7,00,000/-

You are therefore requested to lodge Zero FIR so that proper Investigation could be initiate on time.
