Sir,

I have the honour to state that on 27<sup>th</sup> May, 2023 at @ 00:30 am, received a reliable input from own source that some illegal arms and ammunitions are being kept concealed with one Manoharmayum Barish Sharma S/o M. Balraj Sharma at his house located at Wangnei Ningthem Pukhri Mapal, Imphal East, Manipur. Accordingly, the matter was put up before the senior officers and a combine team of CDO/IE and Imphal East District Police immediately searched the house of M. Barish Sharma by observing necessary formalities. In that, the following arms were recovered from his possession:

- i) One Glock 17 Gun along with a magazine bearing no. LDK328.
- ii) One Glock Gun along with a magazine bearing no. SNM885.
- iii) One Glock empty magazine.
- iv) One Steyr Mannlicher Pistol along with a magazine.

So, the recovered arms were seized and arrested him by observing formalities from the spot.

Therefore, the seized arms along with the arrested person are hereby hand over to you for favour of kind perusal and further necessary action please.
