I have the honour to report that on 4/5/2023 at around 10:00 am our locality New Checkon Imphal East under Porompat Police Station was attacked by thousands of violent mob belonging to the Meitei community with an intent to murder the Kuki residing in the area.

In the process, they looted all the household properties and later vandalised the house including my certificates and document.

The total cost of my properties they damaged and destroyed are estimated to be more than 1.5 lakhs only.

I therefore requested you to kindly take up necessary action as per law of the land.
