It is to inform you that, on the 4th May 2023 at around 1 pm, unknown miscreants attacked Hrokip Neng Palace compound, Imphal. The unknown miscreant numbering about 1000+ people suspected to be the members of Arambai Tengol, Kangleipak Kanbadup, Meitei Leepun and Meitei Si Bemend committee pelted stones and damaged our properties and also looted all our precious belongings and later burnt down our houses. In the incidence, my house was also badly damaged properties worth around 47 lakhs.

You are therefore requested to lodge 200 FIR so that proper investigation could be done on time.
