Sir,

It is to inform you that on the 4th May 2023 at around 1pm, unknown miscreants attacked Hakeip Veng Palace compound, Imphal. The unknown miscreants numbering about 1000 people suspected to be the members of Arawkai Tengol, Kanglipak Kanba Lup, Meitei Keepun and Meitei Sanbemand committee pelted stones and damaged all the house windows. After wards they forcefully entered our house and damaged our properties and also looted all our precious belongings and later burnt down our houses. In the incidence, my house was also burnt down and so many other valuable electronics materials were also looted away and damaged properties worth around 37 lacs.

You are therefore requested to lodge Zero FIR so that proper investigation could be done on time.
