The unknown miscreants numbering about 1,000 people suspected to be the members of Arambai Tengol, Kangleipak Kanba Lup, Meitei teepun, and Meitei ST Demand Committee pelted stones and damaged all the house windows. Alterwards they forcefully entered our house and damaged our properties and also looted all our precious belongings and later burnt down our houses. In the incidence, my house was also burnt down and so many other valuable electronic materials were also looted away and damaged properties worth around 42 lakhs.

You are therefore requested to lodge Zero FIR so that proper Investigation could be done on time.
