I have the honour to report that on the 6th May, 2023 at around 7:30 pm, an unruly mob of Meitei Community numbering around 200/300 suspected to be Arambai Tenggol, World Meitei Council, Kangleipak Kanba Lup, Meetei Leepun forcefully intruded into my rented house with an intend to murder at Nongpok Ingkhol Leikai Ward No. 21, Opposite to KBC Centre Church, New Checkon, Imphal, P.O & PS-Porompat, Imphal East, Manipur. As a result of which all the properties belonging to me were damaged after looting my valuables household properties and burnt down into ashes.

The value of vandalized properties and looted in my rented house will be estimated as Rs. 15, 72,200/- (fifteen lakhs seventy two thousand and two hundred approximately)

I, therefore, humbly, request you to look into the matter and take necessary legal action in your good office.
