I have the honour to state that on 3rd May, 2023 at around 7:00 pm, some unknown miscreants belonging to the Meitei Youth Organization suspected to be members of Arambai Tenggol, World Meitei Council (WMC), Meitei Leepun, Kangleipak Kanba Lup (KKL) and Scheduled Tribe Demand Committee (STDC) numbering about 1500 members attacked my House at New Lambulane, Imphal East. They looted all valuables and vandalized my house. The approximate value of loss and destroyed properties is about Rs 20 lakhs.

It is therefore, requested to kindly registered a regular case and take necessary legal action according to law.
