I have the honour to state that on the midnight of 4<sup>th</sup> May 2023 at around 10pm, some unknown miscreants belonging to Meitei Youth Organisation suspected to be members of Arambam Tengnaf carrying sophisticated weapons numbering about 200 members forcefully entered and attacked our locality (New Lambulane) Imphal ransacking, burning and looting our houses and properties. They also attacked us threatening our lives in which we narrowly escaped. They have destroyed our properties with the approximate value of 40 lakh.

I therefore requested you to kindly registered a regular case and take necessary action according to the law.


