I have the honour to state that, on the midnight of 4<sup>th</sup> May, 2023 at around 10:00 pm some unknown miscreants belonging to Meitei Youths Organization suspected to be members of Arambai Tenngol who are loyal group to the present Inner MP, Shri Leishemba Sanajaoba, World Meitei Council (WMC), Meitei Leepul and Kangleipak Kanba Lup (KKL) and Schedule Tribe Demand Committee (STDC) numbering about 2000 (two thousand) members carrying sophisticated weapons like AK rifles with vehicles forcefully entered in my courter residence located at New Checkon, Mandop Leikai, they looted all valuables and destroy the house. The approximate value of lost and destroyed properties to about 20 lakhs aprox.

It is therefore, requested to kindly registered a regular case and take necessary legal action according to law.
