With due respect I the undersigned would like to inform you that on 4th May 2023 at around 1:00pm a group of Meitei Organisation numbering more than one thousand suspected to be Aambai Tuzogot, Kangleipak Kanba Lup, Meitei Keipum with the help of the Manipur Police commando attacked my residence at Aakhip Veng, Palace Compound Mahabali Road and ransacked and vandalized and burnt down my private place along with one two wheeler and estimated value of properties damaged is around 80 lakhs and house value of 75 lakhs.

It is therefore requested to lodge FIR in connection with this incident at the earliest.
