Sir,

Most humbly and respectfully I would like to bring to your attention the attack on KBC Centre Church, New Lambulane, IF. Our church was attacked twice on the 3rd of May 2023, the first attack happened at around 8:00 pm where they tried and failed to burn the church but set ablaze a two wheeler parked at the compound. The second raid was at around 10:30 pm during which they trespassed into the church and destroyed the property of church. Following ~~on~~ which on Friday the 5th of May 2023 noon, the raiders looted the church and then claimed the church as their by hoisting 7 striped colored flag (Sakai Taret Phiral) on the top of the church tower which still has not been taken down as of now.

All the damage incurred has been enclosed.
