Lam hereby informing you that at about 01:00 PM to 02:00 PM on the 29th of May 2023, some unknown miscreants suspected to be Meiteis, dwelling by the road running along the west of Officer Colony close to the nearby river took advantage of the current law and order situation in Manipur, attacked my residential premise and vandalized my nouse situated at Missioniane (Near Kingsway School Main Gate), Sanjenthong, Imphal East District, Manipur After illegally entering the said premise by forcefully breaking down the gate, the said miscreants went on to damage my official vehicle (Swift Dzire -- white colour ) bearing Registration No. MN01X5658 allotted to me by the H'ble High Court of Manipur. The said miscreants then forcefully broke the windows and broke open the doors of my house and engaged in looting the various movable properties kept inside. On seeing the miscreants forcefully breaking into the premise, some residents of Missionlane and Dimdailong warned the miscreants about the dangers of setting the house on fire as it could spread to other non-Kuki houses in the locality. However, the miscreants told the persons confronting them to mind their own business and at the same time assured the persons confronting them that they will not torch the house but that they are only breaking into the premise/ house to steal the movable properties kept inside. The stolen / damaged goods or movable properties includes Smart TVs, Furnitures, Printers, Laptops, Washing Machine. Water pumpset, Clothing items, etc. Meanwhile, they also stole various construction / equipments/ fools such as water pumpsets, several power tools, shovels, etc. and some bundles or Tist bars stored at the ground of the house. The estimated value of the destroyed and Loren properties stands approximately at Rs 1358500 (Rupees Thirteen lakh hity eight thousand and five meaderd only) and the list of the same is enclosed as ANNEXURE-A.

The aforementioned acts are not only condemnable but are criminal acts and as such the culprits need to be booked under the appropriate sections of the Indian Penal Code 1860.
