As a result, all the household materials were reduced to ashes. A car that was parked at his residence was also burnt down. One fire service personnel namely Thongam Malemngam (30) old (1) Th. Billa of Wangkhei Ayangpalli sustained injury on his person while extinguishing the fire.

Hence a case under FIR no 498(6)023 PRI-PS 445 435/436/34 IPC is registered on suo motto for investigation.

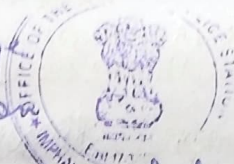
