As a result, all the household materials were reduced to ashes. A car that was parked at his residence was also burnt down. One fire service personal namely Thongam Malemngamba (30) S/O. (1) Sh. Billa of Wangkhei Ajangpalli sustained injury on his person while extinguishing the fire.

Hence a case under FIR no 498 (B) 023 PRI-PS 45 435/436/34 IPC is registered on suo motu for investigation.
