

With due respect, I am to bring to your kind notice that on the 10th May, 2023, at around 12.00 PM, my residence located at Soibam Likai, District- Imphal East, Manipur, P.O. & P.S. Paompat and that because of the ethnic conflict prevalent in the State, some unknown well arm miscreants belonging to the Meitei community on being targeting our village and its villagers to gutted down our houses and bodily harm the people to the extent of death, with no means of defence and security from the State's Government leaving us hapless, on being feared for our life, deserted our village leaving behind all our assets and home, a total estimated at an amount of Rs. 12,50,000/- was left behind at the mercy of the above mentioned well arm Meitei miscreants and now currently resides at Dorcas Veng New-Lanka, C.C.P.

Therefore, I kindly request you to please take action in this matter and come up with positive solutions at the earliest.
