

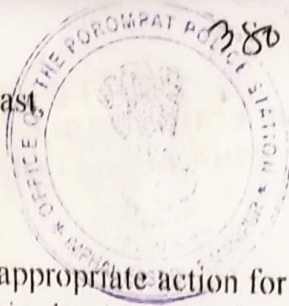

This is to draw your kind attention that I am a Sub-contractor on behalf of the contractor B.D. Sunehson Anal, 1st class Govt. Contractor, Thorcham village, Chakpikarong Sub-Division, Chandel

1. That, I have completed 90% of the aforesaid construction work as per guide line as well as work agreement.

2. That, the construction materials were lost/stolen which was kept at the work site are mentioned as below:-

(xiii) 2.5 wire -1 Coil (xiv) Concrete Mixer Machine - 1No. (xv) Drilling machine - 1 No. (xvi) Welding machine - 2 Nos. (xvii) Hammer Drilling Machine - 1 No. xviii Fixing of state emblem.

The value of the aforesaid materials as calculated for an amount of Rs. 19,76,149/-.

It may be mentioned that the above materials were lost or stolen during the period of present ethnic crisis and the information has come to my knowledge on last 26th June, 2023.

So, I therefore pray that respected Sir may kindly to consider my humble request and please to take appropriate legal action for compensation of the value of lost/stolen goods as mentioned above at an early date.
