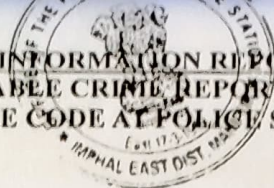

I am to bring to your notice that on the 3rd & 4th of May....., 2023 at 10:00 pm..... a Church Building located at New Lambulane, Imphal East Dist..... owned by Mizoram Presbyterian church Synod Manipur Area, aka Tangphai Presbyterian church was attacked, destroyed and looted by a Group of Meeteis/Meiteis.

These criminals broke open the gate(s), destroyed, looted and vandalized every valuable properties from the premises which is worth Rupees10 Lakhs..... (Aprox.)

Therefore, with utmost respect I request you to take strong action against the perpetrators by registering an FIR under relevant sections of the Indian Penal Code.
