With due respect, I the undersigned would like to introduced myself as Rev J Thanglur presently working as Secretary of Mission Field, ICI Secretariat General Head Quarter, Sielmat and would like to make a report to your good office about vandalism and burning down of **Church building, Pastor Quarter and Office of Independent Church of India (ICI) located at Mission Compound, New Checkon, Imphal P.O & P.S- Porompat & District- Imphal East on 03-05-2023 at 3:45 Pm** by Meeitei/Meitei's goons suspected to be members of the Arambai Tengol and Meeitei Leepun along with women folk.

At the very outset, that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 03-05-2023, on the said day of 03-05-2023 some Meeitei/Meitei's goons suspected to be members of the Arambai Tengol and Meeitei Leepun enter the compound of our Church at around 1:30 pm started to vandalized and destruct all the Church building including all the property which was kept inside the church and building of the Pastor Quarter which was attached with the church worth Rs. ~~2,35,000/-~~ (Rupees Two Lakh and Thirty Five Thousand) only. *Rs. 7,43,250/-*

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future.
