At the very outset, that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 03-05-2023, on the said day of 03-05-2023 some Meeitei/Meitei's goons suspected to be members of the Arambai Tengol and Meeitei Leepun enter the compound of our Church at around 1:30 pm started to vandalized and destruct all the Church building including all the property which was kept inside the church and building of the Pastor Quarter which was attached with the church worth Rs. 2,35,000/- (Rupees Two Lakh and Thirty Five Thousand) only.
