



Sir,

I have the honour to report that, on 14th June, 2023 at around 1:00 AM, some unlawful valley based organisation viz. Arambai Tengol, Meitei Leepun, Kangleipak Kanba Lup (KKL) had looted my rented residence (House owner name - Lalthangjam) at New Lambulane, PS - Porompat, Imphal East. In the incident, the miscreants have stolen my Two wheeler Activa 5G bearing Regd. No. MN01 - 5444 (Red Colour), Washing machine, Fridge, Computer Desktop, Almirah, Bed Box, Sofa set, 3 Cylinders with full gas each, 2 Gas Stoves, Gas box, 3 Sintex 500 ltrs each, Utensils, some important documents, clothes and other items.

The approximate value of looted properties is estimated to be about Rs. 5,00,000/- (Five Lakhs).

I couldn't report the incident in time to the concerned Police Station due to the prevailing law & order situation.

I therefore, request you to kindly take necessary action according to law.
