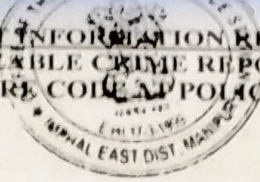

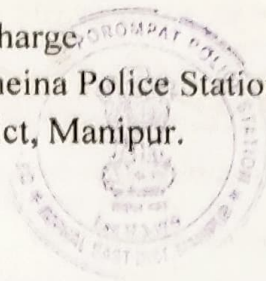

Sir,

With due respect, I have the honour to report that, on dated 04-05-2023 at around 8:00 am, group of miscreants belonging to Meitei community numbering more than 500 people, by holding various deadly weapons attacked our locality at Haokip Veng, Imphal, PS- Porompat.

In the incident, the miscreants have attacked at my rented house (House owner – Tn. Alun Haokip), vandalized and looted my household properties and finally burnt down my house and all left behind household properties into ashes.

The approximate value of destroyed/looted/burnt properties is estimated to be about Rs. 10,00,000/- (Rupees Ten Lakhs only).

I could not report the incident to my concern Police Station as well as in time due to the prevailing situation in the state.

I therefore kindly request you to take necessary action in this regard.
