Subject: Report

Sir,

I, the undersigned have the honour to state the following few lines for your kind perusal and taking further necessary action.

On 4th May 2023 around 10 AM the unknown miscreant suspected to be Arambam Tenggol, Kangleipak Kanba Lup (KKL) and Meitei Leepun attacked Chassad Avenue Imphal and have chassed us out from our rented home. We left the resident including all our furniture and properties along with the office assets located at Chassad Avenue (near Brighter Academy).

That, we left our home and were given Shelter at 1st MR for 6 days, after which we were shifted to Sapormaina till now. We are now homeless and local people have arranged a shelter place for us.

On 13th of June 2023 we come to notice that the doors of our house were open and all the furniture and Office assets were lost along with documents. The amounting worth of assets of office and our belonging were worth of INR. 17 Lakhs.

I could not report the incident to my concerned Police Station in time due to the prevailing law and order situation of our state.

I, therefore, request your good office to kindly take up necessary action in this regard.
