Sir.

I, the undersigned have the honour to state that large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Moreh town on 3rd May, 2023 looting and ransack/burnt down of my house/shop and remaining left over on 28th May, 2023 at around 4:30 pm. The said unidentified groups vandalized/burnt down my house/shop located at Moreh Ward No. 6 and looted all valuable items on 28/05/2023 at 4:30 pm. In that unfortunate incident, I have lost a total amount of Rs. 47,80,000/- (Rupees forty seven lakhs eighty thousand) only. After the said unfortunate incident/mob violent, my family flee our village and my family is taking shelter at a relief camp (Ideal Girls's College) situated at Akampat, Imphal East District, Manipur now shifted at Kakwa Naorem

It is, therefore, prayed that respected Sir may kindly initiate and take necessary legal actions against the accused persons and the persons involved in the said inhuman acts and monstrous crime committed by the accused persons and persons involved as per laws of the land as early as possible.

I shall be grateful for your kind co-operation and necessary action(s).
