I am to report that on the 4th of May, 2023 at @ 1:30 pm, my rented home situated at Haokip Veng, Mahabali Road, P.S. Porompat, Imphal East, was attacked by a radical Meetei mob.

The criminals broke opened the entrance door of my rented house and destroyed, looted, vandalized and burnt down all my belongings and household properties comprising of the followings -

- (1). Furniture Set worth Rs. 5 Lakh.
- (2). Traditional shawl and garments worth Rs. 7 Lakh.
- (3). Household utensils worth Rs. 1 Lakh.
- (4). Electronic gadgets worth Rs. 1 Lakh.
- (5). Clothing and accessories worth Rs. 2 Lakh.
- (6). Semi pucca house worth Rs. 20 Lakh.

The total loss is estimated to be in region amounting Rs. 36, 00,000 (Rupees Thirty Six Lakh) only. Fortunately, all family members managed to escape from the criminals.
