I have the honour to report that on 04-05-2023 at @ 1:40 pm, my rented house, which house my Studio/music class Room, and a Hostel, situated at Haokip Veng, Mahabali Road, P.S. Porompat, Imphal East, (House owner- Tongkhai Haokip) was attacked by a group of Meitei miscreants, in the present communal flare up. In that, they have trespassed into my property and vandalised, destroyed, burnt down and looted properties as listed below-

Properties destroyed at Studio/Music class room:

- 1. Musical Keyboard-15 nos, worth 15 X Rs. 40,000= Rs. 6 Lakhs.
- 2. Acoustic Guitars, 23 Nos, worth 23 X Rs.10,000 = Rs. 2,30000/-
- 3. Electric Guitars, 12 nos., worth 12 X Rs.90,000 = Rs. 10,80,000/-
- 4. Electric Drums 1 no. worth Rs.70,000/-
- 5. Guitar Combo Speaker, 2 nos. worth: 2x Rs. 15,0000 = 3 Lakhs.
- 6. P.A Speakers and Amplifier, worth Rs. 7 Lakhs.
- 7. Guitar effects processors, 4 nos. worth 4x Rs.120000 = Rs. 4, 80,000/-
- 8. Music Recording set-up equipments, laser printer worth Rs. 5 Lakhs.
- 9. Other studio items and accessories worth Rs. 12 Lakhs.
