- (2). Furniture Set worth Rs. 3 Lakh.
- (5). Electronic gadgets worth Rs. 3 Lakh.

- (8). Household utensils Rs. 1 Lakh.
- (9). Jewellery and other ornaments worth Rs. 2 Lakh.
