



Subject: Report on looting, vandalism and burning of properties.

Sir,

I am to report that on the 4<sup>th</sup> of May, 2023 at about 1:30 pm, a residential home, owned and registered in my name bearing Dag No. 4413/4416/4473, Patta No. 38/233(N) situated at Haokip Veng, Mahabali Road, P.S. Porompat, Imphal East, was attacked by Meitei miscreants.

The criminals broke opened the gate and forced us to move out of the house. Thereafter, they destroyed, looted, vandalized and burnt down my residential building and other belongings noted below.

- (1). Two-storey RCC pucca residential building worth Rs. 3,00,00,000 (Rupees Three Crore).
- (2). Four two-wheeler, details of which are as under –
  - (a). Honda Dio bearing no. AS01BQ-5820 worth Rs. 50,000.
  - (b). Honda Activa bearing no. MN01AF-3844 worth Rs. 1,05,000/-.
  - (c). Honda Access bearing no. MN06-5G-9795 worth Rs. 1,10,000/-.
  - (d). Honda Activa bearing no. MN01-AF-3844 worth Rs. 1,05,000/-.
- (3). 4-wheeler Car KIA Seltos bearing no. 23BH-2068B worth Rs. 15,80,000/-.
- (4). Furniture Set worth Rs. 5 Lakh.
- (5). Electronic gadgets worth Rs. 3 Lakh.
- (6). Variety Store and all its components inside the premises worth Rs. 10,00,000/-.
- (7). Clothing and other garments – Rs. 2 Lakh.
- (8). Household utensils – Rs. 2 Lakh.
- (9). Jewellery and other ornaments worth Rs. 10 Lakh.
