

Subject: Report against criminal intimidation, vandalism and arson attack on Evangelical Churches Association and all its properties that took place on 4th May, 2023 at around 1:40 PM at Haokip Veng, Imphal East within Porompat PS.



Sir,

I, the undersigned, on behalf of the Evangelical Churches Association, have the honour to state the following few lines for your kind intervention.

That, on 04-05-2023 at around 1:40 pm, heavily armed unknown miscreants/goons from the Meitei Community attacked, vandalized and burnt down our said Church attached with Pastor Quarter, which was occupied by Pastor Henkhosei Touthang, Area Pastor, Imphal Pastorate Area, ECA-ECCI, and IPA Library, all of which are standing upon a land under Patta No. 1182 covered by C.S. Dag. No. 5414/5623, Imphal East.

As a result of the attack and arson, the following properties worth Rs. 3,50,00,000/- were lost.

1. Two-storey pucca building (Church) worth Rs. 3,00,00,000/-.
2. Church property (Sound system and furniture) worth Rs. 15,00,000/-.
3. Area Pastor Quarter building worth Rs. 21,40,000/-.
4. Furniture set (Pastor quarter building) worth Rs. 3,00,000/-.
5. IPA Pastor Library worth Rs. 5,00,000/-.
6. House-hold utensils worth Rs. 1,00,000/-.
7. Electronic gadgets worth Rs. 3,00,000/-.
8. Clothes and garments worth Rs. 1,00,000/-.
9. Two-wheeler Platina Bike bearing no. MN01C-1833 worth Rs. 60,000/-.
