2. Laptop (HP) worth Rs.54,000/-
3. One Guitar worth Rs. 20,000/-
4. Kitchen wares worth Rs. 30,000/-
5. Clothes and garments worth Rs. 40,000/-
6. Books and documents worth Rs. 20,000/-
7. Electronic gadgets worth Rs. 30,000/-
8. Gas Stove worth Rs. 3,000/-
9. Gas Cylinder worth Rs. 3,000/-
10. Mattress and Cushion worth Rs. 20,000/-
11. Furniture set worth Rs. 70,000/-

Total - Rs. 3,90,000/- (Rs. Three Lakh Ninety Thousand) only.

It is, therefore requested, to kindly take up necessary legal action against the unknown culprits. Cause of delay in reporting on time is due to my displacement and the prevailing law and order situation.
