



Sub: Zero FIR regarding burning of my car by unknown persons during mob violence in Imphal, Manipur.

Sir,

My car was burnt by some unknown persons on 4th May 2021 at around 2pm (afternoon) during the mob violence which happened at Imphal, Manipur and reported in the national news media recently. The situation is still not normal till date. On that day, my vehicle was parked at my parent's house address in Imphal:
