Sir,

I have the honour to state that, on 04-05-2023 at around 4:20 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-1500 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality, Chassad Avenue, New Checkon, Imphal East. They vandalised my rented house and looted all the moveable properties, cash alongwith all the household properties including Shop(tailoring shop), Jewellery, Furnitures, Electronic Items, Utensils, important Documents, Clothes and grains etc.

The approximate value of lost property is calculated at about Rs.40,00,000/(Forty Lakhs).

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
