They vandalised my rented house and looted all the moveable properties, cash alongwith all the household properties including Shop(tailoring shop), Jewellery, Furnitures. Electronic Items, Utensils, important Documents, Clothes and grains etc.

The approximate value of lost property is calculated at about Rs.40,00,000/(Forty Lakhs).

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
