

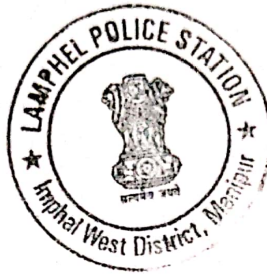



In above fact that I would like to request you to investigate the matter at your earliest convenience.


