With due regard, I the undersigned have the honour to state few lines for your kind consideration and needful action.

That, on 09/12/2022 I had deposited a sum of Rs. 6, 25000/- (Rupees, Six Lakhs and Twenty Five thousand) only as down payment, Rs. 6,250/- (Rupees, Six Thousand ,Two Hundred and Fifty) only as processing fee and Rs. 5,00/- (Rupees, Five Hundred) only as application fee to one Taorem Arun Singh, aged about 31 yrs S/o Taorem Amusana of Govindagram Awang Leikai who is a Manager of Avatar Solutions located at 1<sup>st</sup> Floor Opposite Airport Assam rifles gate, Changangei Makha Leikai, Imphal West District on giving assurance to me by him for giving a loan of a sum of Rs. 25,00000/- (Rupees, Twenty five Lakhs) only and to dispatched the said loan to me by him after 25 days which I shall utilized the said money on the Kidney Transplant and other medical expenses of my son namely Hijam Ambrita Singh. The said money which I deposited to him had been borrowed from others on interest. Thereafter, the given days for dispatching the loan by him had gone over, I had made several attempt to meet him and even tried to contact him through mobile phone. But all become in vain; he had been absconded from the said office by locking the office door neither pick-up the phone call which I rang. As days goes on and my son illness become crucial and also the money which I saved and borrowed had already been deposited to him. So, I become much helpless to my son and also to my other family member.

Therefore, I request you to kindly take necessary action against the said Taorem Arun Singh for his act of cheating by trapping the innocent peoples and to recover the money which I deposited to him. Thanking you for your kind co-operation.
